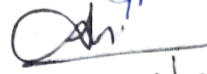
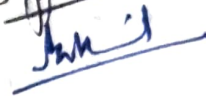
Decided to field Dr. Nishad K.K. and Dr. Nandakish P.C. as AKPCTA candidates in the election to staff Council.

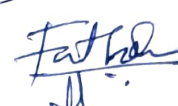

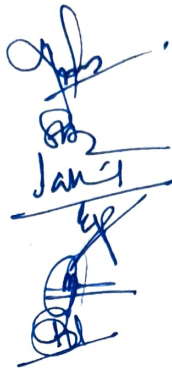
